Requirements:

1. Participating artists must:
 - be residents of Chatham County and/or have a working studio located within Chatham County.
 - be professional working artists/craftspersons
2. Work sold on the Tour must be designed by the artist and the majority of the work produced by the artist.
3. Artists from outside the county or outside the jury process may not participate, show or sell their work at any studio which is part of the Open Studio Tour event.

Artists who meet the above requirements and who have been on the Tour in one or more of the previous two years (2008, 2009) need not be juried. These artists must complete the Returning Artist Application, pay the established fee and meet the deadlines set by the Board.

Committees:

Artists must serve on one or more committees or pay the higher fee. Generally, artists will be assigned to one committee, however, some tasks are small and others are large and there may be need for fill-ins. The Board will make committee assignments. Refer to attached Committee list for new descriptions.

Fees:

The fees to participate in the Tour are **\$225** if you work on a committee, **\$325** if you do not.

Deadline:

Applications, images and fees are due for returning artists on **April 30, 2010**.

I will deliver my artwork to the Chatham Artists Guild on the premises of CCCC and hereby agree to allow the Chatham Artists Guild to exhibit my artwork at its discretion and in the manner it deems appropriate. I, for myself, my heirs and assigns, understand and agree to release and indemnify and forever hold the Chatham Artists Guild and CCCC, their respective partners, affiliates, officers, directors, employees, agents, successors and assigns harmless from all claims, demands, liabilities, loss, expense (including reasonable attorney fees), judgments, and actions of any person resulting in any damage to, theft of, or other loss related to my artwork while it is exhibited at CCCC and until such time as I retrieve it from the premises of CCCC. I hereby agree to accept the terms and conditions of this contract. Neither the Chatham Artists Guild nor CCCC provides any warranties, expressed or implied I have carefully read this agreement and release of liability and fully understand its contents I am aware that this is a release of liability and a contract between myself, the Chatham Artists Guild and CCCC and I sign it of my own free will.
